<b>2. Crime and Safety</b>	Review of village policing arrangements in particular:- (a) Anti-social behaviour (b) Pedestrian safety, vehicles parking on pavements, more pedestrian crossings? (c) Higher Police presence / visibility	<p style="color: blue;">A meeting between the Parish Council's Police Liaison Working Party and the Police Reassurance Project took place on September 21<sup>st</sup>. There is now to be an open Public Meeting to see how the village residents can assist the police in the major areas of concern namely anti-social behaviour and litter. This is now most likely to be in January 2007. There is an ongoing issue of anti-social behaviour on and around the Spoil Bank and Leysland Estate which is drawing police attention and not awaiting public debate and action.</p>
<b>3. Health and welfare</b>	Local Health and Welfare concerns including:- (a) Discuss formation of a Patient Participation Group with Village Health Centre.	<p style="color: green;">See April 2006 update - action points now closed.</p>
<b>4. Traffic</b>	Review of Traffic Calming scheme to reassess existing scheme and discuss any alternatives including:- (a) Safety cameras / "Too fast" signs (b) Mini-roundabouts (c) Investigate concerns of rat runs e.g. Gwendoline Drive (d) Parking problems at Greenfield School	<p style="color: blue;">Electronic speed signs to be installed this financial year on Winchester Road. Slight increase in vehicle usage noted in Gwendoline Drive. We are told there are no plans to change anything at the moment either in Gwendoline Drive or at Greenfield's School. The situation is still being monitored though.</p>
<b>5. Retail</b>	Areas for improvement:- (a) Lack of a DVD/ Video shop (b) Too many fast food shops (c) Pubs in village do not cater for "a quiet meal with friends" (d) Poor parking facilities – limits shoppers.	<p style="color: green;">See April 2006 update - action points now closed.</p> <p style="color: blue;">Police to be firmer with drivers parking illegally on Station Road</p>

Letters to the local College and High School have been sent - it is a national social problem as well a local one. The Parish Council do not feel able to enter <b>The Best Kept Village Competition</b> until this situation has been remedied. This decision will be communicated to the Village in the near future. The Council request <b>everybody</b> to take responsibility for keeping their Village tidy.</p> <p><b>Working Party recommends a Parish Council discussion to agree a way forward. See <a href="#">action point 2</a></b></p>
	<p>(b) Target areas for litter picking</p>	<p>Still a big problem as the litter is dropped quicker than it can be picked up. Letters to the local College and High School have been sent - it is a national social problem as well a local one. Everybody in the Village should 'own' this problem and be part of enabling a litter free Countesthorpe.</p> <p><b>Working Party recommends a Parish Council discussion to agree a way forward. See <a href="#">action point 2</a></b></p>
	<p>(c) Dog fouling also seen to be an issue, as number of bins increases seek to encourage and if necessary enforce clean street campaign</p>	<p style="text-align: center;"><b>See April 2006 update - action points now closed.</b></p>
	<p>(d) "Pollution" was also seen to include Mobile phone masts. Strong feeling against these particularly near the schools and residential areas</p>	<p style="text-align: center;"><b>See April 2006 update - action points now closed.</b></p>

<b>10. Sport recreation and religion</b>	Youth provision is seen as poor. Good sports facilities exist but this does not serve everyone and has limited impact during the evenings when groups of youths gather. This leads to complaints of the lack of recreational facilities leading to anti-social behaviour amongst a minority:- (a) Investigate the need for extra facilities for young people.	See April 2006 update - action points now closed.  Parish Council have started a Tuesday 'drop in café' for young people and hope to see it grow as the month's progress. Parish Council have made a donation to help this project. Young people have made a presentation to the Council at the October Council Meeting which was appreciated and informative.
	(b) Develop disused railway between Countesthorpe and South Wigston as Public Amenity / Walkway / Footpath.	See April 2006 update - action points now closed.
	(c) Investigate facilities for senior citizens	No progress

<b>11. Communications</b>	Whilst the Herald is very popular there is a need for better communications:- (a) Village web site & (b) Village Directory	See April 2006 update - action points now closed. Booklet now delivered to every house in Countesthorpe. Free copies held in the Library, Parish Office and Rainbow Shop.
	(c) Improved use of notice boards.	The Parish Council have agreed to fund the first of three new Notice Boards in the village. The notice board outside the Village Hall will soon have a map of the Village on it as well as space for Parish and Public Notices. <b>September 2006 Notice Board and Map outside the Village Hall now fitted. October, Maintenance Committee to discuss whether to put an additional NB alongside as there is not enough room for all the notices.</b>
	(d) Investigate the provision of a new post box on Rosebank Road	Letter sent to the Post Office from the Parish Office requesting a review of this item. No further news to report. <b>Post Office reply indicates they will not provide any extra post boxes. Council have written again to see if any movement on this decision can be encouraged. Still awaiting reply.</b>
