<u>A meeting of the Finance Working Party was held in the Village Hall, Station Road, Countesthorpe, on</u> <u>Wednesday 11th June 2025</u>

Cllr M Smith chaired the meeting.

- <u>Election of Chairman</u>
 This item was deferred until the next meeting of the Finance Working Party.
- 2. <u>Apologies for absence, if any</u> Apologies were received from Cllr S Turner.
- 3. <u>To receive disclosures of interest</u> There were no disclosures of interest.
- 4. <u>To review the Terms of Reference</u>

This item as deferred until the next meeting of the Finance Working Party. There was discussion as to whether the Finance Working Party documents be made available to all Councillors prior to the meeting to allow more time for them to consider the documents prior to the Parish Council meeting. It was recommended to discuss this further at the Parish Council meeting.

- <u>To verify accounts for payment</u> It was recommended to approve the accounts for payment for the Parish Council and the Village Hall.
- 6. <u>Review budget and expenditure 2024/2025</u>

The budget as at 31st May was received and all was in order.

It was noted that the national pay offer was currently being considered by the Unions who had been issued with a deadline of 23rd June to provide a response. It was noted that it was proposed for the bottom point of the payscales to be deleted from the 26/27 Financial Year, therefore in due course, it would be forwarded to the HR Committee to consider any action that may be needed in future financial years.

Further to the recent Health and Safety Inspection:

. To obtain additional information and costings, if appropriate, for the installation of a smoke alarm in the main hall

. To not proceed with servicing the trolley jack but to purchase a replacement in the future if required, and to implement additional safety measures if and when the existing trolley jack is used

7. <u>Renewal of insurance schedule – Gallaghers</u>

It was noted that, due to a change to the policy, an updated quotation was being produced but had not yet been received. The existing policy had been extended by Gallagher in the meantime.

- 8. <u>Reinstatement/revaluation cost assessment</u> It was noted that the order had been placed for the revaluation cost assessment however that the report had not yet been received.
- 9. <u>Replacement vehicle</u>

Initial costings for the purchase of a vehicle to replace the John Deere mower were presented for consideration and would remain a rolling item for discussion. Lease costings would also be obtained for comparison.

- Review bank signatories and online banking list <u>Recommended for approval</u> To remove outdated bank signatories from the online banking system.
- 11. Grant aid
 - i. <u>Countesthorpe Cricket Club</u> Recommended for approval

To respond to Countesthorpe Cricket Club to advise that Countesthorpe Parish Council would not be offering a grant in response to their most recent request. However, again, that it would be happy to consider either a smaller and more achievable project or to reconsider the current request once other funding had been obtained.
