			The Parish Council asks that the residential properties opposite the site are consulted.

Countesthorpe Parish Council still has concerns about the potential impact on the residential properties, and on the highway.

The Parish Council notes that the Design and Access Statement still refers to the installation of the following:- "Planning permission is sought to install 4 x 18m LED Floodlights around our main pitch.". As this is a discrepancy with the application description and drawings, the Parish Council therefore requests that the application should be revised and resubmitted with an accurate Design and Access Statement. There is also a discrepancy with regard to the hours that the lights are proposed to be in operation. This information should also be clarified and reconsulted on.

The Parish Council recognises that this site is a valuable community asset but it needs significant improvement particularly with regard to the car parking to make it fit for purpose. Users of the facility already park on the highway and block the pavements. The increased hours will exacerbate this situation. The existing car park is insufficient and is often not usable due to waterlogging.

2025/26.069 Housing development updates (if any)

The following updates were received and discussed:

a. Keepers Farm

There was nothing to discuss.

b. Peatling Road

There was nothing to discuss.

c. Cosby Road

Leicestershire County Council's Highway's response regarding the Cosby Road application was noted.

d. Foston Road

It was noted that a representative from Miller Homes had reconfirmed their acceptance of the Planning Committee's invitation to attend a future meeting to discuss construction management processes, however had stated that it would be preferred to wait until the roundabout design was finalised.

Confirmation had also been received that Allianz, the Contractor employed to complete groundworks on the site, would also be responsible for completing works to the roundabout.

i. Blaby District Council consultation – street naming

Blaby District Council's Building Control Department had reconsulted on street names for the Foston Road development with it being resolved to not submit a response as the newly proposed street names were deemed acceptable for the site.

e. Willoughby Road

There was nothing to discuss.

f. Gillam Butts

There was nothing to discuss.

g. Solar Farm

It was noted that application 24/0734/FUL, Soars Lodge Solar Farm, had been granted planning permission at the most recent meeting of Blaby District Council's Planning Committee, with an additional condition having been added during the meeting.

h. S106 wishlist – also to be included as an agenda item on the Parish Council agenda

The current S106 'wishlist' which had previously been submitted to Blaby District Council was again reviewed and amended. This would be further discussed at the next meeting of the Parish Council.

i. Whetstone Pastures

It was reported that representatives for the Whetstone Pastures development had contacted the Parish Council to offer a presentation regarding the development. This would be referred to the Parish Council at its next meeting.

The public consultation was noted as beginning during the week commencing 8th September. Publicity material had been received and shared with residents via Facebook and noticeboards.

A copy of correspondence which had been distributed by a resident regarding flooding at Mennecy Close had been received.
